The meeting was called to order by the Vice-Chairman at 3:05 pm in the conference room of the Registrar Office, County Building #1, in Gloucester. Minutes of the EB meeting for November 1, 2017 were previously approved and posted to Gloucester County Voter Registrar's Web site.

Chairman was absent without a report.

Vice-Chairman had no report.

Secretary had no report.

Registrar reported as follows:

LEGISLATIVE: Bobbi, Albert & Rebecca will be attending Annual Legislative Day Tuesday, January 16, 2018 at St. Paul's Episcopal Church Parish Hall, 815 East Grace Street, Richmond VA — across from Capitol Square. From 8am-4pm. To discuss the 2018 Legislative Overview, meet with Legislators, meet senior staff at The Department of Elections and build support for the Elections Community.

CAMPAIGN FINANCE: Deadline of December 7th, 2017 was met by all candidates and the next deadline is January 16th, 2018.

OFFICE STAFF: Linda Harvey, Assistant Registrar - Last day is Friday, January 26, 2018, we will celebrate her 10 years of service at 1pm, here in the office on that day!

NEXT ELECTION: Primary: Tuesday, June 12, 2018 and the General Election: Tuesday, November 6, 2018.

ELECTION OFFICERS: Will be sending Oath/Response Appointment notices by email to 36 Election Officers that need to renew and to 16 New Election Officers.

TRAINING: Primary Training: 7pm on Wed., May 30, 2018, since Monday is Memorial Day and General Training: 7pm on Mon., October 22, 2018.

VEBA MEETING: Registration deadline: February 16, 2018 At the Homestead. Decide on who will be attending. Leave at 9am on Fri., March 2nd - Return Sun., March 4th (EB will provide report on their individual VEBA Meeting to be given to the Registrar prior to the April Meeting, regarding legislature and other important details)

ELECTORAL BOARD: 2/28/2018 Chairman, Albert Ali, Jr. Term Ends. Democratic Party Chair: Dianne Carter is working on a new person, since Albert has not requested to be re-appointed. Democratic Party Chairs

must make their recommendations to the circuit court by January 15, 2018, also Circuit Courts must appoint newly appointed Electoral Board Members to take office by March 1, 2018.

VOTING BOOTHS: We need to inventory every voting booth with lights and order replacement bulbs for all the ones burnt out.

NEW VOTING MACHINES: All ICE Voting Machines were recalled due a misrouted wiring harness to the inkjet printer, our local vendor came on 12/8/2017 and boxed up all 14 Voting Machines for FedEx PU. All ICE Voting machines will be retested and retrained with the New Dual Monitors by the Vendor for free before the next election.
